## Conditions for Application of Combined Private Hire and Hackney Carriage Driver's Licence

In order that licensed drivers will be reliable and of a good standard, a person being considered for a Driver's Licence subsequently shall:

- a) Be aged 21 or over.
- b) Hold a full UK DVLA driver's licence for at least 3 years.
- c) Have the right to work in the UK.
- d) Submit a fully completed application form.
- e) Pass the Suitability Test (Maths and English requirements) and checks
- f) Be subject to an Enhanced DBS check
- g) Sign up to the DBS update service (after the initial DBS check has been completed).
- h) If any applicant has, from the age of 10 years, spent six continuous months or more living outside the United Kingdom then criminal records information or a 'Certificate of Good Character' from overseas must also be provided.
- i) Have been checked against the National Anti-Fraud Network (NAFN) database on refusals and revocations of Hackney Carriage and Private Hire licence.
- j) Have met the Council's Medical Fitness Criteria which is in line with the DVLA Group 2 standard.
- k) Have met the Council's Safeguarding and Child Sexual Exploitation Awareness Training criteria.
- I) Have met the Council's approved Disability Awareness training requirements.
- m) Have met the Council's Language proficiency requirements.
- n) Have paid the licence fee (please see current fees list).
- o) Have passed the Council's Hackney Carriage Knowledge Test.

## Failure to comply with the above, the licence will be suspended immediately.

All relevant facts will be taken into account when consideration is given to an application for a Driver's Licence and it may be that additional or higher standards will be imposed.

Your suitability to hold a licence will be assessed using the Rochford District Council's conviction policy.
