## NOTICE OF THE PUBLICATION OF THE ROCHFORD DISTRICT LOCAL DEVELOPMENT FRAMEWORK CORE STRATEGY (SUBMISSION DOCUMENT)

Planning and Compulsory Purchase Act 2004 Regulation 27 of the Town and County Planning (Local Development) (England) (Amendments) Regulations 2008

Rochford District Council has prepared a Core Strategy Submission Document as part of its Local Development Framework which it proposes to submit to the Secretary of State under Section 30 of the above Act.

The Core Strategy Submission Document and accompanying documents have been published in order for representations to be made prior to the submission of the Core Strategy to the Secretary of State.

The period for representations to be made is from 21<sup>st</sup> September 2009 to 2<sup>nd</sup> November 2009.

Representations received during the period will be considered alongside the submitted DPD, which will be examined by an independent Planning Inspectorate. The purpose of the examination is to consider whether the LDF Core Strategy complies with the legal requirements and is 'sound' against the tests of soundness.
